

**APPRENTICE NATION
(RockCorps Limited)
Participant Release, Waiver of Liability,
Assumption of Risk, and Indemnity Agreement (the "Release")**

In consideration of RockCorps Limited ("RockCorps") allowing me to participate in any activities related to the 2021 "Apprentice Nation" including, without limitation, participation in community service activities, attending concerts and other events and all related activities (collectively, the "Activities"), I hereby agree as follows:

My responsibilities

1. I fully understand that:
 - my participation in the Activities could include, without limitation, physical activity such as using, moving and working with heavy tools, machinery and materials; contact with unidentified and unfamiliar persons; travelling to and from various unspecified locations; simultaneously participating in the Activities with other participants; participating in the activities in crowded conditions and/or inclement weather; and being exposed to other known and unknown persons, places, circumstances and conditions, both in person and online;
 - the Activities can be HAZARDOUS, and involve known risks and unanticipated risks which could result in:
 - bodily injury, illness or death to myself and to other third parties; and
 - other damage or loss to myself, my property, and to other third parties and their property,which may be caused by my own actions or inactions, those of others participating in the Activities, the locations, places, buildings and/or structures at, on or in which the Activities take place, the conditions in which the Activities take place, or the negligence or misconduct of any of the Releasees (as defined in paragraph 5)
2. I represent that I understand the nature of the Activities. I further represent that I am participating in the Activities voluntarily as an unpaid volunteer and participant, and that I am in good health, physically fit and otherwise prepared and able to participate in the Activities.
3. To the maximum extent permitted by applicable law, I fully accept all the above and other risks and all responsibility for losses, costs and damages (or part thereof) I or any third parties incur as a result of my negligence, recklessness or willful misconduct when participating in or attending the Activities.

Apprentice Nation Responsibilities

4. I fully understand that by this Release, Apprentice Nation is not attempting to exclude, limit or transfer any of its or the Releasees' liability or risk which they are not entitled to exclude, limit or transfer by applicable law.

Release and Indemnity

5. To the maximum extent permitted by applicable law, I hereby forever and irrevocably release, discharge, indemnify and hold harmless Apprentice Nation and all other third parties (including, without limitation, sponsors, partners, licensees, subcontractors and agents and their respective affiliates, permittees, successors and assigns) directly or indirectly involved in or connected with, the Activities (each considered one of the "Releasees" herein) from any and all liability, claims, demands, losses, damages, costs or expenses (including, without limitation, legal fees) (collectively, "Losses") arising out of or in any way related to my negligence, recklessness or willful misconduct when participating in or attending the Activities

Further consent

6. I agree that as further consideration for being permitted to participate in any of the Activities, I hereby grant Apprentice Nation and each of the Releasees, an unrestricted, absolute, universal, perpetual, irrevocable, non-royalty bearing, and transferable right and license (but not any obligation) to use, copy, transmit, distribute, display, modify, perform, present, transform, create works and derivative works, and otherwise promote or utilize my personal attributes (including, without limitation, name, image, likeness, voice and/or other personal attribute(s) or other personal information) captured, photographed or otherwise recorded or memorialized in any manner in connection with any of the Activities, in any medium or format whether now or hereafter existing (including, without limitation, print, direct mail, online, mobile or wireless communications, radio or television broadcast, telecast or photograph), for any purpose whatsoever (including, without limitation, in connection with the creation, advertising, sale and/or promotion of any products and/or services), and without any consideration or notice to or consent by me or any third party.
7. I hereby forever and irrevocably waive any rights I may have in or to any of the foregoing, and I understand and agree that Apprentice Nation and each of the Releasees are the exclusive owners (to the extent the materials are created by or at the direction of each such party) of any and all right, title and interest, including copyright, in and to any materials of any kind or nature containing or developed from use of my personal attributes.

Release and Waiver

8. I have read this Release, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law.
9. I hereby forever and irrevocably waive any and all rights to seek or obtain any injunctive or other equitable relief with respect to any matter within the scope of this Release, or to rescind, limit or disaffirm this Release.

General

10. If any provision of this Release is unenforceable, it shall be modified to the extent reasonably necessary to make the provision legal, valid and binding, and the remainder of this Release shall remain enforceable to the full extent allowed by law.

11. No statements regarding the effect of this Release, not contained in this Release, shall modify the terms of the Release.

12. This Release shall be binding upon the undersigned.

13. I agree that this Release contains the entire agreement, and supersedes all prior agreements and understandings, between me and Apprentice Nation relating to the Activities.

14. This Release shall be governed by and construed in accordance with the laws of England and Wales without regard to conflict of laws principles. I hereby agree to submit to the exclusive jurisdiction and venue of the English courts for any dispute and irrevocably waive any and all rights to object to such jurisdiction.
